

### Current Projects

- Worked cooperatively with BLM to spray in wilderness area for noxious weeds with pack animals . Worked with Shoshone & Paiute tribes to spray for noxious weeds, about 2000 acres, increased the acreage amount sprayed by 500 acres this year to 4500 acres total.

Partnered with USFWS and landowners to control Hydrilla in the Bruneau River.

Partnered with landowners and IDEQ to implement Nutrient Management BMP's on 8000 acres of irrigated cropland within the Bruneau and Grand View Nitrate Priority Areas.

Administration of Quagga mussel check stations at Bruneau and Marsing. Conducted a total of 2853 inspections at the Bruneau station and 1249 inspections at the Marsing station.

NRCS had 14 farm bill projects in the Bruneau Grandview area this year,

The BRSCD provides technical and financial assistance to cooperators through NRCS, SWCC, USFWS, DEQ, and 319 grants and other funding sources to develop and implement BMP's to conserve renewable natural resources.

Our mission is to take available technical, financial, and educational resources, whatever their source, and focus or coordinate them so that they meet the needs of the local land user for conservation of soil, water quality and fish and wildlife habitat.
